The Commission of Railway Safety, working under the administrative control of the Ministry of Civil Aviation of the Government of India, deals with matters pertaining to safety of rail travel and train operation and is charged with certain statutory functions as laid down in the Railways Act (1989), which are of an inspectorial, investigatory & advisory nature, invites applications for the following Post:

**Eligibility Criteria**

Officers under the Central Government or State Governments or Union Territories or Universities or recognized research institutes or public sector undertakings or statutory or autonomous organizations, -

- a) (i) holding analogous posts on regular basis in the parent cadre or Department; or  
(ii) With five years' service in the grade rendered after appointment thereto on a regular basis in level 6 (Rs. 35400-112400) in the pay matrix or equivalent in the parent cadre or Department; and
- b) possessing the educational qualifications and experience: -  
(i) Bachelor Degree in Civil Engineering or Mechanical Engineering or Electrical and Electronics Engineering or Electronics and Communication Engineering or Electronics and Telecommunication Engineering from a recognized University or Institution;  
Or  
(ii) Diploma in Civil Engineering or Mechanical Engineering or Electrical and Electronics Engineering or Electronics and Communication Engineering or Electronics and Telecommunication Engineering from a recognized University or Institution and having two years' experience of duty in a Government Organization in the related subject.

**Note 1:** Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some organization or Department of Central Government shall ordinarily not exceed three years.

**Note 2:** The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date of receipt of application.

**Note 3:** For purposes of appointment on deputation/absorption basis, the service rendered on regular basis by an officer prior to (the date from which the revised pay structure based on 7th Central Pay Commission recommendations has been extended) shall be deemed to be service rendered in corresponding grade pay or pay scale extended based on the recommendations of the Commission except where there has been merger of more than one pre-revised scale of pay in to one grade with a common grade pay or pay scale, and where the benefit will extend only for the post(s) for which that grade pay or pay scale is the normal replacement grade without any up-gradation.

2. Applications of willing officers, fulfilling the above conditions may please be forwarded along with:
  - (i) Bio - Data (In duplicate) as in the Proforma given annexure-A.
  - (ii) Photocopies of ACRs for the last five years duly attested on each page by an officer not below the rank of Under Secretary to the Govt of India.
  - (iii) Vigilance Clearance Certificate.
  - (iv) Integrity Certificate.
  - (v) A statement giving details of Major/Minor Penalties imposed on the officer, if any during last 10 years.
3. One set of complimentary pass and One set of Privilege Ticket Order of appropriate class in a year will be given to employee so appointed in the Commission of Railway Safety, during the period of deputation. However for the Railway employees, normal rules will apply.
4. It is requested that the applications for willing and eligible officers may be forwarded to the "Office of the Commissioner of Railway Safety, South Central Circle, Secunderabad -500025 (in duplicate) in the prescribed proforma (Annexure-A) within 30 days from the date of publication of this circular. While forwarding the application, it may also verified and certified by the employer that the particulars furnished by the applicant (s) are correct.
5. The candidate will not be allowed to withdraw their names in the event of their selection.
6. The applications received after the closing date or other than through proper channel or without ACRs and other certificates as required, will not be entertained.
