**Mode of Selection :** The screened in candidates will be called for interview and candidate will be selected based on the Selection Committee's recommendations.

**Place of Posting:** Initial posting will be at INCOIS, Hyderabad. However, he/she may be required to work anywhere in India.

**Age relaxation:** Since it is an unreserved position, no age relaxation would be applicable for SC/ST/OBC candidates. However, age relaxation is permissible up to five years for those persons having a minimum of three (3) years of regular service in Government organization / Autonomous bodies / PSUs. For Ex-Servicemen, the age relaxation will be as per Government of India guidelines.

- The prescribed essential qualifications are minimum requirements. Mere possession of the same does not entitle any candidate to be called for interview.
- Director, INCOIS reserves the right to cancel the recruitment process without assigning any reason thereof or vary the number of posts to be filled.
- No TA / DA will be paid by INCOIS for attending Interview.
- The list of screened-in candidates and selected candidate(s) will be displayed at INCOIS website.
- Candidates working in Government / Public Sector undertakings / Autonomous bodies are required to submit online application to INCOIS within the due date and time along with the 'No Objection Certificate'.
- Candidates having experience relevant to the job responsibilities are required to upload the experience certificate issued by the current employer with the details of date of joining, date of resignation / leaving if applicable. Appointment orders /resumes, salary statements, etc. will not be considered as proof of experience / current employment.
- Production of the original certificates mentioned in the application is a must while appearing for Interview. Non-production of the original certificates will also make the candidate disqualified for attending interview.
